## INTRODUCTION/BACKGROUND INFORMATION

The Law Reform Commission (hereinafter referred to as "the Commission" or "LawRecom" was established by statute of 18<sup>th</sup> May 2007 by the Lagos State Law Reform Commission Law (hereinafter referred to as "the Law") as amended on 30th January 2012. Its first Commission was constituted on March 12, 2012.

The Commission is an autonomous corporate body and:

- Receives proposals for reform from the State Government and the general public;
- Examines different branches of the Law for reform;
- Prepares from time to time comprehensive programmes of consolidation and statute Law Revision and undertake the preparation of draft legislation for such programme for consideration of the State Executive Council or the State House of Assembly; and
- Provides references particularly in areas of law, which the government through its policies wishes to be reviewed and reformed.

## 2.0 MISSION STATEMENT

To review and reform the law following consultative monitoring with a view to effecting necessary changes to make them modern, fair, just, efficient and

accessible and in consonance with the prevailing social and moral values of Society.

## STRATEGIC OBJECTIVES

- Oversee the operation of all Lagos State Laws with a view to their systematic and progressive development and reform in accordance with changes in social attitudes and prevailing norms in the Nigerian Society and the international community in general;
- Advise on specific legal issues aimed at explaining and clarifying the current law
- Eliminate all anomalies and repeal obsolete, spent and unnecessary enactments and provisions;
- Undertake the consolidation and codification of such laws through the reduction in number of separate enactments including the reform of procedural laws in accordance with changes in the machinery of the administration of justice.

### DIRECTION

The Law Reform Commission shall establish itself as the most efficient machinery for the continuous delivery of quality law reform by its direct efforts and in its co-ordination of other stake-holders in the law reform process. LawRecom's direction and envisaged services should at all times be capable of:

- A constant appraisal of law and order in the territory of the State;
- A survey of the development of society towards a culture of adherence to the rule of law;
- Thorough consultation, research and analysis of the impact of laws;
- Constant monitoring of social and moral, values as well as economic development through qualitative social research;

- Providing modern understandable and clearly drafted law reform bills to enable government have a clear picture of the recommendations contained in its reports and reform proposals;
- Constant revision of the laws of the State as well as codification and consolidation of the laws;
- Maintaining efficient public access to all laws of the State;
- Maintaining good library service, with efficient information technology apparatus;
- Ensuring the release and dissemination of high quality publications in both the print and electronic modes for the dissemination of the commission's publications;
- Providing a good office environment and adequate training for its staff;
- Promoting the implementation of the Commission's Reports and making efforts towards working together with stakeholders to ensure that the Commission's reports are considered; and
- Maintaining a project management system capable of ensuring timely completion of projects and timely delivery of reports.

### KEY SUCCESS INDICATORS

- The extent to which defects in the law can be identified and reform proposal made.
- The quality of draft bills accompanying the Commission's Reports.
- The effectiveness of the Commission's public consultation.
- The efficiency of the Commission's management of its human and material resources and its reform projects.

- Efficiency of measures aimed at promoting the implementation of its reports.
- Level of maintenance of effective liaison with government and non-governmental organizations and oversees law reform agencies on law reform issues.
